Vendor Contract Information

The United States Australian Shepherd Association will have its 2015 National Specialty at the **Purina Farm Events Center**, April 12th – April 17th, 2015. The **climate controlled** Event Center will be the site of our show headquarters, all conformation, agility, obedience, and rally events, and all rental grooming spaces and vendor booths.

Our Nationals begin on Sunday April 12th, 2015 with 2 days of Agility Trials. Conformation, Obedience, and Rally events start on Tuesday April 14th, 2015. There is a two day ASCA show starting on Friday April 10th. If you wish to be set up for this show please mark the “Attending all events” box on page 2 of this form.

Each vendor space is approximately 10'x10'. The fee for each space is \$250 for each set of events. (2 days for Agility or 4 days for Conformation). The fee for those wanting to stay all week is \$350.00. You may reserve multiple spaces in 10'x10' increments. The location of your rented space will be on a first come, first serve basis. We will try to work with those vendors staying over from other shows.

Payment for your fee may be made by check or money order. **You will be sent a confirmation letter giving you specific information regarding move in times/dates once reservations close.**

Vendors are responsible for providing all necessary set up equipment. This is an **indoor, climate controlled** show. Electricity is available, but may be limited.

No vendor fees may be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

Any vendor acting in a less than sportsmanship manner will be asked to leave and no vendor fee will be refunded. Any vendor cancelling less than 2 weeks before the start of the show will not have any fees refunded.
