Vendor Contract Information

The United States Australian Shepherd Association will have its 2017 National Specialty at the **Purina Farms Event Center**, May 10th – May 19th, 2017. The **climate controlled** Event Center will be the site of our show headquarters, all conformation, agility, obedience, and rally events, and all rental grooming spaces and vendor booths.

Our Nationals begin on Wednesday, May 10th, 2017 with 4 days of Agility Trials. Conformation, Herding, Obedience, and Rally events start on Monday, May 15, 2017.

Each vendor space is approximately $10' \times 10'$. The fee for each space is \$175.00 for 4 days of Agility and \$200.00 for 5 days of Conformation for each set of events. The fee for those wanting to stay all week is \$350.00. Please check the box indicating which option you want on your reservation form.

You may reserve multiple spaces in 10'x10' increments. The location of your rented space will be on a first come, first serve basis, with those returning from previous years being offered the prior year's space.

Payment for your fee may be made by check or money order. <u>You will be sent a confirmation letter</u> giving you specific information regarding move in times/dates once reservations close.

Vendors are responsible for providing all necessary set up equipment. This is an **indoor, climate controlled** show. Electricity is available, but may be limited.

RV parking is available through Linda Grant, RV/Day Parking Coordinator, at tyedyed@comcast.net

No vendor fees may be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

Any vendor acting in a less than sportsmanship manner will be asked to leave and no vendor fee will be refunded.
